Deferral of admission to 2021?

Deferral of the admission offer is only possible for EU citizens.

Non-EU citizens are welcome to apply again in 2021.

Degree not available at the moment of matriculation due to covid19?

In case that due to covid19 the official degree and/or transcripts of records and not available at the moment of matriculation, you can request to matriculate without these documents with the promise of providing them during the Winter Semester.

For requesting this, please send evidence of this problem to the coordinator mep.admission@vwl.uni-freiburg.de before 15.10.2020.

The official documents must be presented by 20.03.2021 the latest.

English certificate not available at the moment of matriculation due to covid19?

Matriculation without a valid English certificate is not possible.

Please notice that online IELTS and TOEFL scores are exceptionally accepted in 2020.

Off-campus matriculation due to covid19 reasons

The University of Freiburg offers the possibility of off-campus matriculation for students starting their studies in winter semester 2020/21 and who cannot come to Freiburg on time before the on-site registration deadline October 22, 2020 due to the travel restrictions caused by the covid19 pandemic.

In order to register off-campus, you should go to the online campus management platform and follow similar steps as for on-campus registration in the online modality: [Explanatory leaflet and instructions](#) , [online matriculation form](#), [overview](#). You should scan your official documents and send them per e-mail to the admission office as indicated in the instructions.

If you are matriculated off-campus:

- You will have a regular student status.
- You will be able to attend the online part of the lectures and register for exams (you will still have to come to Freiburg in order to take the exams in February – March 2020)
- You will unfortunately miss the on-site part of the teaching activities until you can come to Freiburg.
- You will be able to register on-campus once you receive your visa even after the registration deadline expires.

Visa

With off-campus registration you do not require visa until you can matriculate on-campus in Freiburg.

Insurance

With off-campus registration you do not require German insurance until you can matriculate on-campus in Freiburg. You will still need to be insured in your home country for the time you are not in Germany. However, the German social insurance policy once you matriculate on-campus should cover the entire semester retroactively, even if you were not in Germany at the beginning of the semester.
